## Camping –

A camping option has been arranged through the local Boy Scout council at Camp Potomac. We will have space for approximately 25 campers at the site. Tents or very small pop-up campers may be used. The campsite contains a small shelter with a stone fireplace as well as a covered pavilion with picnic tables. There will be NO spaces for vehicles after equipment has been dropped off at the site and participants will need to walk from the parking lot to the campsite (approximately 750 feet). Showers and restroom facilities will be available.

There will be a \$10 fee per camper, which can be paid through the ASM website or mailed in. Fees will be donated to Camp Potomac for their use in maintaining the camp. Reservations will not be guaranteed until payment has been received.
